IN CONSIDERATION OF THE PROCESSING BY PACIFIC SANITATION OF THIS APPLICATION, AND/OR THE EXTENSION OF ANY CREDIT TO APPLICANT AND/OR THE MAKING OF ANY SALE TO APPLICANT SUBSEQUENT TO SIGNING OF THIS DOCUMENT BY APPLICANT, APPLICANT (hereinafter "Customer") AGREES AS FOLLOWS:

1. Payment Terms: NET 30 Days. Payment is due 30 days from the date of invoice.
2. Interest shall accrue, on amounts not paid when due, at a rate of 18% per annum or at the maximum rate permitted by law.
3. Customers with past due balances in excess of 45 days will not be allowed further extensions of credit until the account balance is paid in full. Pacific Sanitation may withhold services until said amounts are paid.
4. Customer agrees to pay a \$35.00 fee for any returned check not properly honored by the bank on which it is drawn.
5. Customer agrees fully and promptly to furnish Pacific Sanitation the information needed or requested for proper filling out and service of a 20-Day Preliminary Notice, under the Mechanics' Lien Laws.
6. In addition to any other security given to Pacific Sanitation or that Pacific Sanitation may have, Customer, to the extent of any monies due for services furnished by Pacific Sanitation to Customer to or for a particular project, assigns to Pacific Sanitation any Mechanics Lien, Stop Notice, and/or Bond claims or rights that Customer has or may have in regard to such project under the Mechanics' Lien Laws pertaining to public or private construction, or against contract proceeds or retainages payable to Pacific Sanitation in regard to such project. Customer agrees, upon Pacific Sanitation's request, to execute documents and perform any acts necessary or appropriate to perfect or pursue such claims or rights or to permit Customer to perfect or pursue such claims or rights whether in Pacific Sanitation's name or otherwise.
7. In the event of default of payment when due, or any other disputed between the parties, the prevailing party, in addition to any other relief which the court may grant, shall be entitled to recover the principal amount due with interest, the cost of the dispute, and reasonable attorney's fees.
8. All promises of shipment or delivery are approximated as closely as possible by Pacific Sanitation, but are subject to weather conditions, fires, strikes, disputes with workmen, flood, accidents, delays in transportation and mechanical breakdowns.
9. Financial statements, credit information, information supplied by the applicant or by others on the applicants behalf are a part of this contract. Any false or misleading information constitutes misrepresentation.
10. The person signing this application and contract on behalf of the applicant represents and warrants that such person is duly authorized to do so and that the execution of this application is the lawful and voluntary act of applicant. The undersigned also declares under penalty and perjury that the information provided herein is accurate and complete.
